10. **0:** No protection.
11. **1:** Protection against vertically falling water drops (e.g., condensation).
12. **2:** Protection against water drops falling at a 15-degree angle.
13. **3:** Protection against spraying water at a 60-degree angle.
14. **4:** Protection against splashing water from any direction.
15. **5:** Protection against low-pressure water jets (6.3mm nozzle) from any direction.
16. **6:** Protection against high-pressure water jets (12.5mm nozzle) from any direction.
17. **6K:** Protection against high-pressure and high-temperature water jets (used in specific industries).
18. **7:** Protection against temporary immersion in water (up to 1 meter for 30 minutes).
19. **8:** Protection against continuous immersion in water (beyond 1 meter; specific conditions are defined by the manufacturer).
20. **9K:** Protection against high-pressure, high-temperature water jets (common in food processing and automotive industries).
21. **Additional Letter (Optional):**
Sometimes, an additional letter is included to provide further details about the protection level. These letters are less common but can be useful in specific contexts.
22. **f:** Oil-resistant.
23. **H:** High-voltage apparatus.
24. **M:** Device moving during water test.
25. **S:** Device standing still during water test.
26. **W:** Weather conditions.
