Introduction

- Refining and Smelting:** Purifying raw materials consumes large amounts of electricity, particularly in regions reliant on coal-based power.

Key Contributors:

• **Cobalt (for batteries):** Mostly mined in the Democratic Republic of Congo, where artisanal mining

has severe environmental and social consequences.

• **Lithium (for batteries):** Extracted from brine pools or hard rock mines, requiring massive water usage and energy.

• **Rare Earth Elements (for screens and processors):** Mining these elements generates toxic waste and high CO₂ emissions.

B. Manufacturing and Assembly

Once raw materials are processed, they are assembled into components such as:

• **Semiconductors and processors** (e.g., Apple's A-series chips, Qualcomm Snapdragon)

• **Displays (OLED/LCD screens)**

• **Batteries (lithium-ion)**

• **Circuit boards and memory chips**

Key Emissions Sources:

• **Energy-Intensive Factories:** Most smartphone manufacturing occurs in countries like China, South Korea, and Taiwan, where coal and natural gas dominate electricity generation.

• **Chemical Processing:** The production of semiconductors involves hazardous chemicals and high-temperature processes, increasing energy demand.

• **Water Usage:** Semiconductor fabrication requires ultra-pure water, which is energy-intensive to produce.

C. Distribution and Retail

After assembly, smartphones are transported globally via air, sea, and land freight, contributing to emissions. Additionally, retail packaging (plastic, cardboard, and protective materials) adds to the carbon footprint.

D. Usage Phase

While the **usage phase accounts for only 10-20% of a smartphone's total emissions**, it still contributes due to:

• **Charging:** The electricity used to charge a phone depends on the energy mix of the user's country (e.g., coal vs. renewables).

• **Data Usage:** Streaming, cloud storage, and app usage increase demand on data centers, which consume vast amounts of energy.

E. End-of-Life and Recycling

Only **20% of e-waste is formally recycled**, with the rest ending up in landfills or informal recycling centers (e.g., in Ghana or India), where toxic materials leach into the environment. Improper disposal leads to:

• **Methane emissions** from decomposing organic materials in landfills.

• **Loss of valuable metals**, requiring new mining and processing.

2. Quantifying the Carbon Footprint of a Smartphone

Studies estimate that the **average smartphone generates 55-85 kg CO₂e** over its lifetime (typically 2-3 years). However, this varies by brand, model, and usage patterns.

A. Brand-Specific Carbon Footprints

iPhone 13 Pro	~74	80%	16%

- Screen Size & Resolution:** Larger, higher-resolution displays require more energy to produce.
- Battery Capacity:** Larger batteries (e.g., for gaming phones) increase lithium and cobalt demand.
- 5G Technology:** 5G-enabled phones have more complex antennas and processors, raising emissions.
- Manufacturing Location:** Factories in countries with renewable energy (e.g., Norway) have lower footprints than those in coal-dependent regions.

3. Environmental and Social Consequences

A. Climate Impact

- The **global smartphone industry emits ~125 million tons of CO₂e annually**, equivalent to the emissions of **26 million cars**.
- If smartphone production continues at current rates, emissions could **double by 2030**.

B. Resource Depletion

- Lithium and cobalt reserves** are finite, with demand projected to outstrip supply by 2030.
- E-waste is the fastest-growing waste stream**, with only **17.4% recycled properly** (UN Global E-waste Monitor 2020).

7. **Apple** and **Samsung** have committed to **100% renewable energy** for manufacturing.
8. **TSMC (Taiwan Semiconductor)** is investing in **low-carbon chip production**.

B. Extending Smartphone Lifespan

1. **Software Updates:**
2. Longer software support (e.g., **Google's 5-year updates for Pixel 6**) reduces the need for new devices.
3. **Refurbished and Second-Hand Markets:**
4. Platforms like **Back Market** and **Apple Refurbished** promote reuse, cutting demand for new phones.
