9. **Phone Support** – Call the manufacturer's support line.
10. **Email or Web Form** – Some brands allow claims via email.
11. **In-Store Appointment** – If available, schedule a visit to an authorized service center.
12. **Provide Required Information**
13. Serial/IMEI number.
14. Proof of purchase.
15. Description of the issue.
16. Photos/videos (if requested).
17. **Follow Instructions for Repair or Replacement**
18. The manufacturer may:
 - **Mail you a shipping label** to send the device for inspection.
 - **Direct you to an authorized repair center.**
 - **Send a replacement device** (if available).

B. Filing a Claim with the Seller (e.g., Amazon Renewed, Back Market, Gazelle)

1. Visit the Seller's Warranty Claim Page
2. **Amazon Renewed:** [Amazon Device Support](#)
3. **Back Market:** [Back Market Support](#)
4. **Gazelle:** [Gazelle Support](#)

5. Log In to Your Account

6. Most sellers require you to be logged in to process a claim.

7. Initiate a Warranty Claim

8. Select the device and describe the issue.

9. Upload proof of purchase and any requested documentation.

10. Follow the Seller's Instructions

11. Some sellers may:

- **Send a replacement device** before receiving the defective one.
- **Provide a return shipping label** for the faulty phone.
- **Offer a refund or store credit** if the issue cannot be resolved.

12. Ship the Device (If Required)

13. If the seller requests the phone back, package it securely and use the provided shipping label.

14. Remove any personal data before sending it.

Step 5: Track Your Claim and Follow Up

After submitting your claim:

1. Save the Claim Reference Number

2. This helps track the status of your claim.

3. Check for Updates

4. Most warranty providers send email updates.

5. Log in to your account on the seller's or manufacturer's website to monitor progress.

6. Follow Up if Necessary

7. If the claim is taking longer than expected, contact support for an update.

8. Be polite but persistent if the issue isn't resolved in a reasonable time.

9. **Prepare for Possible Outcomes**

10. **Repair** – The device may be fixed and returned to you.
11. **Replacement** – You may receive a refurbished or new device.
12. **Refund or Store Credit** – If the issue can't be fixed, you may get a partial or full refund.
