 12. Tests for color fading and material degradation under prolonged sunlight exposure.
 13. **Button & Port Functionality Testing**
 14. Ensures buttons remain accessible and ports (charging, audio) are not obstructed.
 15. Often tested through **10,000+ press cycles** for durability.
