Steps for the Previous Owner:

1. **Sign in to iCloud.com** using their Apple ID.
2. Go to **Find My iPhone > All Devices**.
3. Select the locked device.
4. Click **Erase [Device]** (if not already erased).
5. After erasing, click **Remove from Account**.

If the Previous Owner is Unavailable:

â?? Request a **proof of purchase** (receipt or invoice) from the seller.

â?? Contact **Apple Support** with the proof to verify ownership.

3. Provide Proof of Purchase to Apple

If you are the legitimate owner but cannot recall your Apple ID, Apple may assist if you provide **valid proof of purchase**.

Required Documents:

â?? Original **receipt or invoice** (must include device serial number).

â?? **Credit card statement** (if purchased online).

â?? **Apple Store purchase confirmation email**.

Steps:

1. Visit [Apple Support](#) or an **Apple Store**.
2. Provide the **serial number** (found on the device or original packaging).
3. Submit proof of purchase for verification.
4. If approved, Apple will **remove the Activation Lock**.

Note: Apple does **not** guarantee unlocking, especially for devices reported lost or stolen.

4. Use Apple's Official iCloud Removal Service (For Businesses & Education)

Apple offers an **official iCloud removal service** for businesses, schools, and organizations that manage multiple devices.

Eligibility:

• Devices must be part of **Apple School Manager** or **Apple Business Manager**.

• The organization must have **purchased the devices directly from Apple or an authorized reseller**.

Steps:

1. Log in to **Apple School Manager** or **Apple Business Manager**.
2. Navigate to **Devices** and select the locked device.
3. Click **Release from Organization** (if applicable).
4. Follow the prompts to remove the Activation Lock.

For Individual Users:

This method is **not available** for personal devices.

5. Check for Carrier or Third-Party Unlocking (Limited Cases)

Some **mobile carriers** or **authorized third-party services** may assist in removing the iCloud lock under specific conditions:
