2. Ask the Seller to Remove Activation Lock Before Purchase

- The seller should **sign out of iCloud** and **erase the device** before selling.

 - Go to **Settings > [Their Name] > Sign Out**.
 - Enter their Apple ID password.

4. Verify the iPhone's Purchase History

- Ask the seller for the **original receipt or proof of purchase**.

5. Buy from Reputable Sellers

- **Apple Refurbished Store** • Apple sells certified refurbished iPhones with no Activation Lock.
- **Authorized Resellers** • Best Buy, Amazon Renewed, and carrier stores often sell unlocked devices.
- **Trusted Marketplaces** • Swappa, Gazelle, and Back Market verify devices before listing.

What to Do If You Accidentally Bought an iCloud-Locked iPhone

If you've already purchased a locked iPhone, here are your options:

1. Contact the Seller for a Refund

- If the seller misrepresented the device, request a **full refund**.
- Provide proof (screenshots, IMEI check results) that the phone is locked.
