Attempting to use a SIM card from another carrier will result in the phone displaying an error message or refusing to connect to the network.

How Do Phones Get Locked?

1. **Subsidized Pricing** — Many consumers purchase phones at a discounted rate when signing a contract or opting for an installment plan. The carrier locks the device to ensure the customer stays with them for the duration of the contract.
2. **Preventing Theft & Fraud** — Locking phones reduces the resale value of stolen devices, making them less attractive to thieves.
3. **Customer Retention** — By restricting phone usage to their network, carriers encourage customers to remain with them rather than switching to competitors.

How to Check if a Phone Is Locked

If you're unsure whether your phone is locked, you can check using these methods:

- **Insert a SIM from Another Carrier** – The simplest way is to insert a SIM card from a different provider. If the phone displays a message like “SIM Not Supported” or “Network Locked,” it is carrier-locked.
- **Contact Customer Support** – Call your carrier’s customer service and ask whether your device is locked.
- **Check Settings (iPhone)** – On an iPhone, go to **Settings > Cellular > Cellular Data Options**. If “SIM Locked” appears, the phone is locked.
- **IMEI Check** – Some online tools allow you to enter your phone’s **IMEI number** (found in Settings or by dialing *#06#) to check its lock status.

What Is an Unlocked Phone?

An **unlocked phone** is a device that is not tied to any specific carrier. It can operate with any compatible SIM card from any network provider, both domestically and internationally. Unlocked phones are either:

- **Purchased directly from the manufacturer** (e.g., Apple, Samsung, Google) at full retail price.
- **Previously locked but later unlocked** by the carrier after fulfilling contract obligations.
- **Sold by third-party retailers** (e.g., Amazon, Best Buy) as unlocked models.

Types of Unlocked Phones

1. **Factory Unlocked** – These phones are sold directly by the manufacturer without any carrier restrictions. They are the most flexible and often the most expensive upfront.
2. **Carrier-Unlocked** – These phones were originally locked but have been officially unlocked by the carrier after the contract period ended or the device was paid off.
3. **Third-Party Unlocked** – Some sellers or services claim to unlock phones, but these may not always be legitimate or fully functional. It’s best to use official carrier unlocking methods.

 - You **don't want to be tied to a contract**.

How to Unlock a Carrier-Locked Phone
